GAO Releases No Audit Opinion on Federal Government's Financial Statements

Comptroller General Gene Dodaro appeared before the House Oversight and Government Reform Committee last Wednesday to discuss the U.S. Government Accountability Office's annual report on the audit of the consolidated financial statements of the U.S. government. The report, which also looked at efforts to increase the use of performance information in government, also highlighted that the U.S. Office of Management and Budget and the federal agencies are missing opportunities to use such information more effectively.

GAO identified three long-standing issues which prevented them from issuing an opinion on the federal government's 2012 consolidated financial statements:

- Serious financial management problems at the Department of Defense.
- The federal government's inability to adequately account for and reconcile intragovernmental activity and balances between federal entities.
- The federal government's ineffective process for preparing the consolidated financial statements.

Regarding performance information, GAO found "...the results from our 2013 managers' survey show almost no statistically significant changes in managers' perceptions of their leaders' and supervisors' attention and commitment to use of performance information since our last survey in 2007."

House Subcommittee Delves into Medicaid

With the deadline approaching fast for States to set up their health insurance exchanges, the

House Energy and Commerce Subcommittee on Health took a look at Medicaid expansion issues last Monday. The hearing, entitled "Making Medicaid Work for the Most Vulnerable," examined the current state of the Medicaid program in light of existing pressures related to growing enrollment trends, scarce resources, and barriers for patients in accessing quality care.

Panelist Alan Weil, executive director for the National Academy for State Health Policy, told the subcommittee that "While the nation debates the future of Medicaid and the future of the health care system, Medicaid is the only practical option millions of vulnerable Americans have for meeting their health care needs." He also cited examples within states that have received federal support to test health care delivery system reforms through the Centers for Medicare and Medicaid Innovation's State Innovation Models cooperative agreements:

- Arkansas is focusing on a populationbased care delivery model.
- Minnesota seeks to integrate medical care, community health, public
